a. President's Report

President Craig Guensler thanked everyone for attending today's meeting.

# G. Information and Discussion Items

- a. Health Comp: Dawn Goodman / Renee Stout
  - i. Plan Document Amendment

Renee Stout introduced Dawn Goodman to the board and explained that Dawn is part of the compliance team at HealthComp. She has worked with TCSIG for a long time and is very familiar with the TCSIG Plan Document and she works hard to keep TCSIG in compliance with any required changes.

Dawn Goodman stated there were some significant changes that needed to be made to the TCSIG Plan Document. She then reviewed the Executive Summary that highlighted the changes that were made to the TCSIG Plan Document. The summary said HealthComp amended the Plan Document and Summary Plan Description for the Employee Health Care Plan to reflect the end of the Public Health Emergency pertaining to COVID-19, and the enactment of Title I (the No Surprises Act) of Division BB of the Consolidated Appropriations Act, 2021. Ms. Goodman then went through a redlined copy of the TCSIG Plan Document showing each change.

The changes related to the ending of the COVID-19 emergency ending were no longer waiving the cost for COVID testing, no long covering over the county COVID test kits or requiring to provide eight tests per family member per month, waiving the cost for out-of-network COVID vaccines or waiving the deductible on the CDHP plan for COVID related services. COVID Vaccines having been added as a preventative benefit when obtained by an in-network provider.

The changes implementing the No Surprises Act include prohibiting balance billing, continuity of care and amending the definition of Emergency Medical Condition and Emergency Services. The balance billing is specifically for emergency services for out-of-network providers or facilities, certain non-emergency services from out-of-network providers at in-network hospitals or ambulatory surgical centers, and out-of-network air ambulances. Providers in this situation would be reimbursed at Qualified Payment Amount (QPA) which is the median of the contracted rates for the same or a similar

service provided in the same or similar specialty in the same geographic region. If a provider is not satisfied with the QPA they can request to negotiate with the Plan and if they are still not satisfied, they can request an Independent Dispute Resolution (IDR). For Continuity of Care members can receive care for up to 90 days when a provider leaves the Anthem network, but the provider must accept the network reimbursement rate. Also, there are limited types of treatment that are allowed under Continuity of Care which are identified further in the TCSIG Plan Document.

The amendment to Emergency Medical Condition and Emergency Services requires any immediate medical treatment be covered by the Plan even if the services are excluded by the Plan. This coverage also includes emergency room care and pre-stabilization services that were provided after the member is admitted to a hospital and additional services given after the member is stabilized as part of Emergency Services. The last section updated in the TCSIG Plan Document was text related to the Consumer Directed Health Plan (CDHP). These updates clarified that TCSIG does not contribute to Health Savings Accounts, it reflects the specialty pharmacy benefits, and it removed references to first dollar benefits for mental health benefits and deductible carryover because these are not permitted by the IRS.

- b. Wellness Within: Bridget Connealy
  - i. Introduce Cancer Program

Bridget Connealy from Wellness Within introduced a no cost cancer support program to the TCSIG board. Wellness Within is located in Roseville, CA and also offers online services. Their program offers services to cancer patients, survivors, and their loved ones. The program was founded by Patty Brown who was a psychologist and now it is run by two cancer survivors. Ms. Connealy then walked the board through the Wellness Within website which has offers podcasts, classes, videos, nutrition services, and lessons/modules on different issues cancer patients, survivors or loved ones can face. All lessons are self-paced and are a great support tool for members. Ms. Connealy also stated their program has been vetted by Sutter, UC Davis, and Kaiser.

- c. Winner Chevrolet Colfax, CA: Casey Dekoning
  - i. Opportunity for Fleet Vehicle Purchases

Casey Dekoning and Jerry Powers from Winner Chevrolet presented to the board regarding fleet vehicle purchases for TCSIG districts. Mr. Dekoning stated their company will deal directly with the districts for flee vehicle purchases instead of having to go through a dealership. Mr. Powers then said they are 100% focused on fleet vehicles and have found a better way to streamline the process to make it more effective.
