- a. County of Yuba Treasurer & Tax Collector: Jolie Turk
  - i. Review Yuba County Treasurer's Investment Policy

Marisa Garramore introduced Yuba County Treasurer & Tax Collector, Jolie Turk. Ms. Turk has been with Yuba County for 15 years and was appointed as the Treasurer & Tax Collector in May of 2024 and her term will end in 2026. Once the term has ended, she will be running for the position. She noted there have not been any changes to the investment policy. Ms. Turk has continued to follow the investments of the previous Treasurer & Tax Collector and when she checked TCSIG's investments were doing well. She is very happy the investments have gone up nearly 1%. Ms. Garramore stated TCSIG interacts with Yuba County daily for transfers and deposits. She said they are very easy to work with and always willing to help TCSIG. Ms. Turk confirmed that they have a fantastic relationship with TCSIG.

Kuldeep Kaur asked Ms. Turk if TCSIG is affected by a system issue that Yuba County Treasurer has been experiencing. Ms. Turk stated yes that currently, activity reports are not available and unfortunately, they do not know when the system will be fixed or when the interest information will be available. Once the reports are available, she will send them out.

Ms. Garramore stated that Nisha Johnson checks the bank daily to see what checks have cleared and sees a potential problem if the interest information is not available by June.

Kevin Trutna asked if Yuba County has an Investment Oversite Committee. Ms. Turk said no there is not. The committee was disbanded prior to her tenure at Yuba County.
